

Metes & Bounds Description to 78.42 Acres James W. Winters Survey, A-904 Leon County, Texas

BEING 78.42 acres, more or less, situated in the James W. Winters Survey, A-904, Leon County, Texas, and being all of that certain called 78.385 acre tract described in a deed from Robert A. Lacey, Independent Executor, to Cathryn Louise Lacey, dated September 29, 1980, and recorded in Volume 484, Page 345, Deed Records, Leon County, Texas. Said tract to be more particularly described by metes and bounds as follows:

BEGINNING at the southeast corner of the referenced tract at a found 36" Post Oak. Said point being the southwest corner of a called 77.45 acre tract described in Volume 1572, Page 665, and being in the northern margin of County Road 114;

THENCE SOUTH 59° 45' 48" WEST 672.07 feet, with the margin of County Road 114, to a ½" iron rod (set with cap marked "C-TEX") at a fence corner for the common corner of the referenced tract and a called 0.935 acre tract described in Volume 656, Page 544;

THENCE NORTH 15° 00' 16" WEST 856.76 feet, with the common line of the referenced tract and said 0.935 acre tract, to a ½" iron rod found for the north corner of said 0.935 acre tract and being in the eastern line of a called 78.385 acre tract described in Volume 495, Page 826 (reference Volume 491, Page 685);

THENCE NORTH 07° 14' 28" EAST 3657.96 feet, with the common line of the referenced tract and said 78.385 acre tract, to a capped ½" iron rod set in the southern line of a called 4.824 acre tract described in Volume 494, Page 553. From said point, a found ½" iron rod bears South 83° 31' 51" West 56.47 feet;

THENCE NORTH 83° 31′ 51″ EAST with the common line of the referenced tract and said 4.824 acre tract, at 868.00 feet pass a concrete sewer tile for the common corner of said 4.824 acre tract and a tract conveyed to Ann Sadler in Volume 462, Page 297, and described as 378 acres in Volume 299, Page 242, and continuing with the common line of the referenced tract and said 378 acre tract for a total distance of 1213.14 feet to a point at the southern base of a large Elm fence corner for the northwest corner of a 78.385 acre tract described in Volume 1572, Page 665. From said point, a capped ½" iron rod set for reference bears South 18° 33′ 03″ West 0.60 feet;

THENCE SOUTH 18° 33' 03" WEST 3502.41 feet, with the common line of the referenced tract and said 78.385 acre tract, and with the common line of the above mentioned 77.45 acre tract, to a capped ½" iron rod set;


THENCE SOUTH 14° 59' 47" EAST 967.08 feet, with the common line of the referenced tract and said 77.45 acre tract, back to the place of beginning and **containing 78.42 acres**, more or less, as shown on the accompanying survey plat of even date herewith.
